The Department, in our equality scheme, are committed to consultation using 'a variety of consultation methods and although the press isn't mentioned specifically I think it would be a good idea to place an advert in both English and Irish.

I have no doubt the screening will lead to a full EQIA but as you are already going out to consult on the policy this can be attached. You are also required to proof new policies for environmental, rural, regulatory, health, and sustainable development impacts and the Integrated Impact Assessment(IIA) tool will assist - link attached. I would advise you speak to the Policy Innovation Unit, OFMDFM to see what is required in terms of the IIA for your policy.

Finally, I would have some concern with your timescale. Do you have the necessary, up to date data at hand to clearly demonstrate why the policy is to be screened in or out? I have had a very quick look through the consultation paper, and what is very concerning is that there is no mention of having screened or EQIAd this policy. DCAL would need to be explicit in outlining their equality considerations in the document, which they have not done as yet. One would imagine, given the nature of the subject matter, that this would be screened in and a full EQIA required. In my view, it would make sense that any consultation would be within the context of the EQIA - otherwise one would have to consult twice. Once on options (what they are referring to as an "open" consultation in this case) and then again as part of an EQIA. If they go with option A as a result of the earlier consultation, and then found that there were potential adverse impacts, where would that leave the Dept? I have spoken to DCAL Equality Unit and I understand they have already provided advice along the lines of that outlined above, but it would appear not to have been heeded in this case.

The references to section 75/promoting equality of opportunity in the document are very vague. The line you have flagged up "the Section 75 equality provisions of the Northern Ireland Act 1998 and the Human Rights Act 1998 provide a general legal framework for the protection of the individual's right to express and celebrate his or her own culture" is completely erroneous. Section 75 does not protect individual's rights - it is a positive promotional duty on public authorities to promote equality of opportunity. There is a world of differnce,

With regard to Human Rights, the above statement does not actually provide any information on the human rights engaged by the proposals. Without having the time to look at it in detail, it would appear that at the very least Art 10 (freedom of expression) is involved. Potentially there may be Art 9 (freedom of thought, conscience and religion) and Art 14 (prohibition of discrimination) issues also. DCAL need to undertake a Human Rights Impact Assessment on their proposals in order to ensure that they have fully considered all of the human rights issues. At the very least, there needs to be a more systematic consideration of the human rights implications.

In the section entitled The language scheme approach it says "In Northern Ireland there is already experience of applying similar statutory schemes in respect of equality of opportunity under section 75 of the Northern Ireland Act. What does this actually mean?

Also, there are numerous uses of a phrase "should be treated on a basis of equality" - what does this mean? When talking about s75 there is a need to

be explicit about what it is you mean. I would caution against using phrases like this which have no meaning in law and are very open to interpretation.

I would therefore suggest that DCAL are advised to revisit this document before it is issued. Key stakeholders with an interest in this area will be highly critical of the lack of explicit references to equality and Section 75 in particular. The first port of call should be for them to go to their Equaltiy Unit and speak to them, and to listen to the advice that they have been given. As this is a highly sensitive subject it is likely to come in for a lot of scrutiny.

Can you reconcile Bernie's comments that we have not heeded Equality Unit's advice, when Damian advised me yesterday that we can screen and conduct the EQIA on the policy proposal (which won't be determined until at least March 2007) and not on the options paper (he used the phrase 'preconsultation' which is technically correct but not a phrase we intend to use to describe the paper)? I was not advised that 2 EQIAs should be conducted, which I think is what Bernie is suggesting.

The advice I got yesterday from Damian was passed directly to Judena, and the email below suggests that I either misinterpreted what he said (which I didn't), or that I have decided not to take his advice (his advice was as above).

Just so I am absolutely sure before Judena gets a response from HOCS - can I get a definite line from Equality Unit on whether or not we have to screen the current consultation paper, in accordance with current statutory duty? (Also - I have never heard of Human Rights Impact Assessment!)

I haven't seen Damian's advice, so I can't comment on what he said, and he's not in until Tuesday. The advice I have seen is that the policy is likely to be screened in and an EQIA consultation could be attached to the consultation you are already committed to doing. This advice also contained a link to the Integrated Impact Assessment Tool

services/policylink/policylink-integrated-impact-assessment.htm . The Human Rights Impact Assessment is part of this tool.

Having not seen the document it is impossible to advise on the content beyond the advice already offered, and I can't interpret it without knowing what this was. I wouldn't interpret Bernie's comments as 2 EQIAs, but 2 consultations - one now and one later for an EQIA if the proposal the Department chooses is screened in, <u>as we have advised it is likely to be</u>. Again, I haven't see the options, I can't be specific. Bernie's point is that if this consultation identifies an option which is not compatible with Section 75 the Department will be left in an awkward position if we did not consider Equaltiy Implications of each of the options now. I don't know if the options have considered Equality Implications, I am being asked to reconcile comments on a document and on advice which I have not seen.

Damian's advice on 14 November did highlight the need to be thorough with regard to such a high profile policy. Bernie's concerns appear to echo this, again I don't know what the paper says so I can't comment if there is or isn't an explicit reference to equality considerations in developing any proposals.

Apologies for not being able to give a definite line on screening, I can't give a definite answer without all the facts.

Our statutory duty under S75 requires the department to screen all policies to determine whether an EQIA is necessary. In this case I have no doubt that a screening will show a full EQIA necessary. The EQIA requires a thorough and systematic analysis of the policy, making reference to the nine equality categories as defined in S75 of the act. The primary function is to determine the extent of differential impact of the policy upon the groups and whether that impact is adverse. If adverse impact is identified we must then consider measures that might mitigate the adverse impact.

If we agree an EQIA is necessary then the first step in the process is the consideration of available data which will enable you to make a judgement of the extent of impact on the nine equality categories. There is a raft of information available from the work already completed by the department with the Irish Language Broadcast Fund and the European Charter. I would refer you to the consultation document on the Policy on Provision of Financial Support for Irish Language Film and TV Production dated June 2004 that can accessed on our internet site. This will give you an idea of the structure and format and should form an integral part of the consultation document.

I know time is not on your side but if you intend going out to full consultation without considering the equality implications the Department will be in breach of its equality scheme and open to a complaint. The thinking that you will complete the EQIA at a later stage when the policy is agreed will require a further 8 - 12 week consultation period at the end of the process and I would advise against this action.

I hope this is helpful but if you want to discuss things further please let me know.

Further to our conversation yesterday and the proposed way forward - to screen and EQIA the decision to implement the Irish Language Act and to include it in the consultation document - I have spoken to the Equality. Commission this morning to discuss the matter. It is their view that the decision to implement the Act and the consultation on the options are two separate policies and therefore require separate screenings and impact assessments.

I explained our dilemma in that we do not have a specific policy to assess but rather a set of options that we are seeking consultee views on. They stated that we should assess the impacts on each of the options by examining data and research from each of the jurisdictions in which the model is operating and present this in the document to consultees.

We must also consult on our proposed EQIA on the decision to implement the act so it can still form part of consultation document for ease of consultation purposes and cost.

I don't know where this now leaves us but the Commission feels that if we go out without assessing the S75 options it is highly likely we will receive a complaint.

DEPARTMENT OF CULTURE, ARTS AND LEISURE POLICY SCREENING FORM

The Legal Background

Under Section 75 of the Northern Ireland Act 1998, the Department is required to have due regard to the need to promote equality of opportunity:

- between persons of different religious belief, political opinion, racial group, age, marital status or sexual orientation;
- · between men and women generally;
- · between persons with a disability and persons without; and,
- between persons with dependants and persons without.

Without prejudice to the obligations set out above, the Department is also required to have regard to the desirability of promoting good relations between persons of different religious belief, political opinion or racial group.

Schedule 9 of the Act requires the Department to 'assess and consult on the likely impact of policies adopted or proposed to be adopted on the promotion of equality of opportunity', i.e. carry out an equality impact assessment (EQIA).

Screening

In order to determine whether an EQIA is necessary, all policies must be screened. The Department's business areas screened their existing policies in 2000-01 when the equality scheme was being prepared. Significant changes to existing policies and new or proposed policies should be screened for significant equality issues as they arise.

This form is intended to assist you in screening any revised or new policies for which you take the lead and to record the outcome in respect of each policy. It should also be used as a prompt when considering legislative proposals.

The screening procedure should lead to one of these conclusions:

- the policy being screened has an insignificant impact on equality of opportunity; or
- the policy being screened has (or is likely to have) a significant impact

Officials should complete this form for each of the new or revised policies for which they are responsible (see page 2 for a definition of policy). When you have completed the form it should be retained on file for record purposes.

What is a policy?

The Equality Commission has defined 'policies' as 'all the ways a public authority carries out or proposes to carry out its functions relating to Northern Ireland'. The Act defines 'functions' as 'including powers and duties'.

1.5 Responsibility for devising and delivering policy:

Irish Language Bill Team, Department of Culture, Arts & Leisure is responsible for meeting the commitment given in the St Andrews Agreement to introduce an Irish Language Bill reflecting on the experience of Wales and Ireland and work with the Incoming Executive to enhance and protect the development of the Irish language.

2. SCREENING ANALYSIS

When proceeding to screening "proper", the Equality Commission has stated that there are four criteria to be considered. These are listed at 2.1- 2.4 below. You are asked to consider the criteria in relation to the Section 75 groups and to answer the questions accordingly.

"Don't know"?, "No evidence"?

The questions ask for evidence in relation to the Section 75 categories. You should not think of the "don't know" column in the form as the easy option to respond to any of the questions. In cases where you don't know and you don't have data on file, you will need to make a pragmatic judgement based on experience as to whether the policy you are screening may have an impact on any of the categories. If your judgement is that the policy may have a differential adverse impact on any of the Section 75 groups (i.e. it affects them differently and less favourably than other groups), you should seek to obtain evidence. You should note that evidence can be qualitative – i.e. drawn from the experience of individuals from their perspective - as well as quantitative. Officials must give consideration to steps that they could reasonably be expected to take to obtain evidence and thereby inform their decision-making. Such steps could include meeting with a representative group or selective consultation.

Where there is little or no evidence, and common sense indicates that a differential impact may be expected, you should discuss this with the Equality Unit.

PROPOSALS FOR IRISH LANGUAGE LEGISLATION

During the course of our meeting on Friday 10 November 2006 you asked for details of consultation exercises conducted by DCAL which relate to the development and formulation of policy. I apologise for the delay in replying.

Whilst this Department has been engaged in a number of consultation exercises over the past two years, only one of these – The Safety at Sports Grounds (Northern Ireland) Order 2006 - has resulted in legislative change. The basis for this legislation was to introduce a safety certification scheme, similar to that which already exists in Great Britain for larger sports grounds and non-temporary spectator stands. The scheme will be administered and enforced by the District Councils in Northern Ireland.

An initial consultation was conducted between June and October 2004 and a policy proposal was issued in February 2005. Comments on a draft Order and Explanatory Notes were sought between June and September 2005 before The Safety at Sports Grounds (Northern Ireland) Order 2006 was laid in December 2005. The approval of Privy Council was granted in February 2006.

Details of other consultation exercises, undertaken by DCAL, are attached at Annex A.
